Applying for an Application Fee Waiver

To be eligible for an application fee waiver, you MUST be a U.S. citizen or permanent resident.

- 1. Please complete the personal information on the Request for Waiver of Graduate Application Fee. Check the program box on the Request for Waiver form, as appropriate.
- 2. Sign, date, and return this form by **January 15, 2015** to the Graduate Division at the address listed below along with the necessary verification.

Fee Waiver Options

Fee Waiver Option 1: Program Participation

If you are currently participating in one of the following programs, please select the program and attach evidence of your participation in such program: CSU Sally Casanova Pre-Doc. Scholars, AMGEN Scholar, CAMP, Gates Millennium Scholars, GEM, Louis Stokes Bridges Doctorate Program, MARC, MBRS, McNairs Scholars Program, MESA, RISE, UC DIGSS, UC-HBCU Initiative and UC Leads.

Participants MUST submit *verification of participation* in the program for the *current year*, such as a letter bearing the original signature of the program director or adviser, or a copy of the current contract. You do not need to submit financial information.

If you are not a participant in any of these programs, you must demonstrate financial need to be eligible for a Fee Waiver. Financial need is related to family income and size and is based on a federal formula, which calculates a dollar amount available for educational expenses.

Fee Waiver Option 2: Financial Aid

Students who have received financial aid from their current university may be eligible for a fee waiver. Attach one of the following:

- 1. A statement of need from a financial aid officer at the college or university that you are *currently attending*. This statement must include your *Estimated Student or Family Contribution (EFC)*. Your financial aid officer must sign and date the statement before you submit it to us. A photocopy or facsimile of signatures is not acceptable.
- 2. An official award letter for the current year. A copy of a university Student Aid Report (SAR) will NOT be accepted.

Current UC Merced students – if you have completed a FAFSA for the current academic year, you are NOT required to submit a statement of need or official award letter.

Fee Waiver Option 3: Household Income

Household size is determined by the number of people you report or claim on your income tax forms for the previous year. If you are claimed as a dependent, your household size is determined by the total number of people claimed on that tax form. If you are independent and have no earned income, you must document how you supported yourself for the past year and why you do not have sufficient funds to pay the application fee.

1. **Tax documents** - A copy of your parent's or guardian's most recent federal income tax return, if you are listed as a dependent. If you are independent, please submit a copy of your most recent federal income tax return. If your circumstances are unusual and you think that information provided by the documents listed above will not accurately reflect your financial situation, you may also submit a detailed letter describing how the information provided in the supporting documents does not reflect your current economic, social, or educational situation.
